CONSENT MOTION FOR CONSOLIDATION

Pursuant to Fed.R.Civ.P. 42(a), and with the consent of the defendants to the Complaint, plaintiffs California Democratic Party, Art Torres, Yolo County Democratic Central Committee, California Republican Party, Shawn Steel, Timothy Morgan, Barbara Alby, Santa Cruz County Republican Central Committee, and Douglas R. Boyd, Sr. ("California party plaintiffs"), by counsel, respectfully request that the Court consolidate this action with the cases previously consolidated under the caption *McConnell v. FEC*, Civil Action No. 02-582, and in support thereof represent the following:

- 1. Fed.R.Civ.P. 42(a) provides that the Court may consolidate actions "involving a common question of law or fact."
- 2. The Court previously consolidated several cases challenging the constitutionality of the Bipartisan Campaign Reform Act of 2002 ("BCRA"). *See* Order Consolidating Cases, Civ. Action No. 02-582 (D.D.C. April 24, 2002).

- This action, filed May 7, 2002, challenges sections of BCRA on grounds it violates the First, Fifth, and Tenth Amendments to the United States Constitution. Similar issues of law and fact are raised in the consolidated *McConnell* actions, and defendants Federal Election Commission and U.S. Department of Justice already are named or participating in the related cases. Like those cases, this case is subject to § 403(a) of the BCRA, authorizing a three-judge court. Accordingly, the interests of efficient and orderly adjudication of related questions of fact and law will be served by consolidating this case with the *McConnell* actions.
- 4. Plaintiffs' counsel has conferred with counsel for the defendants to this Complaint and they consent to consolidation of this action with the *McConnell* actions.

WHEREFORE, California party plaintiffs request that the Court enter an order consolidating this action with the *McConnell* actions consistent with the terms of the Court's April 24 Order. A proposed Order is attached.
