Presently before the Court is a Motion of Senator John McCain, Senator Russell Feingold, Representative Christopher Shays, Representative Martin Meehan, Senator Olympia Snowe, and Senator James Jeffords ("Movants") to Intervene as Defendants Supporting the Constitutionality of the Bipartisan Campaign Reform Act of 2002. The Court shall grant this motion.

While Movants had originally only sought intervention in *McConnell v. FEC* and *NRA v.*FEC, this Court's May 3, 2002, Order granted Movants the right to intervene in the seven consolidated actions that were before the Court at that time. See McConnell v. FEC, No. 02-582

(D.D.C. May 3, 2002) (order granting intervention).

Movants now seek Intervenor-Defendant status in all of the consolidated actions challenging the Bipartisan Campaign Reform Act of 2002. The motion does not appear to be presently opposed. As such, the Court now extends its May 3, 2002, Intervention Order to permit Movants to intervene as Defendants in the four recently filed challenges to the Bipartisan Campaign Reform Act of 2002, that are consolidated around *McConnell v. FEC*.

Accordingly, it is, this <u>/O</u> of May, 2002, hereby

ORDERED that the Motion of Senator John McCain, Senator Russell Feingold,
Representative Christopher Shays, Representative Martin Meehan, Senator Olympia Snowe, and
Senator James Jeffords to Intervene as Defendants Supporting the Constitutionality of the
Intervene as Defendants Supporting the Constitutionality of the Bipartisan Campaign Reform
Act of 2002 [#44] is GRANTED. Movants are deemed to be Intervenor-Defendants in all eleven actions presently before the Court that are consolidated around McConnell v. FEC.
